2. Expression of Interest (EOI) for Supply, Installation, Operation and Maintenance of Water Treatment Technology for Ranney Wells

3. Background

- Noida is being developed as an industrial town to New Delhi and more and more people from Delhi and other areas are shifting to Noida in search of fresh air, greenery and better infrastructure.
- Presently, Noida receives water from tube wells, Ranney wells and Ganga water. Existing total water production capacity is approximately 569 MLD out of which 81 MLD is through Ranney wells, 248 MLD through tube wells and 240 MLD through Ganga water. In order to ensure good quality of water supply, NOIDA wants to hire a firm to assess the suitable technology on the basis of water analysis report of Ranney well water, and also supply and install required water treatment plant followed by operation and maintenance for 5 years. .
- In order to finalize the technology and other requirements to improve quality of water supply in Ranney wells, the Authority invites Applicants (“Interested parties” or “Bidders”) to submit their EOIs. Based on the responses of EOIs received, the Authority shall finalize and initiate the procedure.
- The issue of this EOI does not imply that the Authority is bound to undertake the Bidding Process and select the Applicant for allotment of the project.

1. About Project

The bidder shall be required to assess the technology suitability on the basis of water analysis report available from the Authority and supply and install followed by operation and maintenance of water treatment technology for a period of 5 years for different Ranney wells. The number of Ranney wells may vary depending on the water analysis report.

The installed capacity of each Ranney well is 18000 KL per day, however, presently it is being used at 50% of the capacity i.e. 9000KL per day .

2. Scope of the project

The scope will include (but not limited to):

Assignment 1 – Assessment of Water Quality

1. To conduct site visits to assess the on-ground situation for 5 numbers of Ranney Wells
2. To collect water analysis report available with the Authority

Assignment 2- Recommending suitable water treatment technology

1. Listing out the various water technology options available
2. Recommendation of the proposed intervention required in terms of water treatment technology
3. Cost comparison of the technology proposed

Assignment 3 – Installation, Operation and Maintenance of the Water Treatment Plant for 5 years

1. Supply and Installation of the finalized technology
2. Operation and Maintenance of the installed water treatment technology for a period of 5 years

3. Eligibility of Bidders

The Bidder may be a single entity or a group of entities (the “Consortium”). Must be a Sole Proprietor/ Registered partnership firm/ LLP/ Public Limited Company/ Private Limited Company

4. Qualification of Bidders

To be eligible for qualification and short-listing, the Bidders shall have to satisfy the following conditions of eligibility

Technical Capacity:

Water treatment plant manufacturing firms with experience of undertaking similar works in supply of technology and operations and maintenance. In case of a Consortium, the combined technical capacity and financial capacity of all the members of Consortium would be considered

5. Selection Process

- The Eoi is issued only with a purpose of collection of information from interested parties and Noida Authority reserves the right to proceed ahead with the Project. However, the applications received shall be reviewed carefully and interactions with the applicants is likely to take place before finalisation of Project terms and conditions.

6. Application Registration and Instructions

- Applicants are advised to study all instructions, forms, terms, requirements and other information in the Eoi carefully.
- Applicant shall be deemed to have applied after careful study and examination of the Eoi Document with full understanding of its implications.
- The response to this Eoi should be full and complete in all respects. Failure to furnish all information required by the Eoi or submission of a proposal not substantially responsive to the EOI in every respect will be at the Applicants' risk and may result in rejection of its eligibility.

7. Site Visit

It is desirable that each Applicant submits its Application after **inspecting the Ranney wells**. A site visit to the Ranney Wells will be organized by NOIDA Jal Department on 10/12/2018 and 11/12/2018 at 15:00 hours. A prospective Applicant interested in attending the site visit will have to notify NOIDA Jal in writing 3 days prior to the scheduled dates mentioned above and reach Noida Jal Office, Sector-37 on the specified dates. The bidder is also required to collect the Water Analysis report from the concerned officials to suggest the best suitable technology.

8. Submission of EOI

- Complete application process will be offline. All the notifications & detailed terms and conditions regarding this Eoi notice hereafter will be published on the Noida Authority web site
- The application should be submitted in hardcopy in a sealed envelope within the deadline as specified in point no.10
- Applicant should fill in information in prescribed formats for Pre-Qualification as mentioned in the Eoi.
- Applicant shall submit all formats and suggested documentary evidence with the EOI document.
